I feel so blessed to be part of such an active and enthusiastic Board. We have fourteen elected members of our congregation that chair various Church committees. Along with the elected personal, we have three staff members, Jody Villadsen, church secretary, Kayla Matzen, Children and Family Ministry Coordinator and Karen Millard, church minister that are integral parts of our church.

It is hard to believe that it is already a year since our last Squamish United Church Annual General Meeting. The past twelve months have flown by and we have accomplished

much over this time. After six or seven years of planning and building we moved into our new facilities at Centrepoint this past summer. Hats off to our Facilities Development Committee for all of the time and energy they put into our new facility to ensure it came in on time and on budget. We held our first service in our new church in September.

The members of our Board were very involved in a variety of initiatives to help fund for various items. In September we held a very successful "Please Be Seated" gala event to purchase 150 chairs for our Sanctuary. This event was designed to showcase Centrepoint as a much needed community venue. We also hosted a wonderful evening of music with all proceeds going to improving the acoustics in our church. Thanks also to the UCW for fundraising that went into purchasing the sound curtains.

We also celebrated and thanked our St John the Devine Anglican hosts with a luncheon in September for allowing us to jointly worship with them for the past couple of years. We really appreciated the warm reception we received from Reverend Parker and his congregation. To help Squamish United Church grow, we invited Consultants Amanda Fenton and Chris Corrigan to work with our Board and our congregation to move forward in developing a healthy and workable strategic plan. They led four or five productive sessions throughout the year and will finish up their work this Spring. Another big project we continued to support this past year was in helping Syrian Refugee families relocate to our community and as such, Squamish is now a safe home to three new Syrian families. This is very exciting to be a part of a Mission and Service project of this magnitude.

We know that 2018 will be an even more exciting time in the life of Squamish United Church as we adjust to our beautiful new facilities and we continue to look forward to our time together in God's name.

Board of Trustees Report

The Board of Trustees had an interesting year in that both our new church sanctuary

and Centrepoint were completed and officially opened. This therefore meant that the majority of our remaining investment funds were expended on the construction costs for the new sanctuary/offices and for furnishing it. It also meant that we became owners of our new building within a strata corporation.



As a strata owner, we still have sole ownership of our sanctuary and offices but we share the ownership of the common spaces – such as parking and gardens – with the

other strata owners, namely Sea to Sky Community Services (STS) and BC Housing. We also have another asset which is a 99-year lease on various meeting rooms within the STS section. For example, this includes the meeting room off the foyer and also the daycare next to the sanctuary.

As of December 31, 2017, we held just under \$250,000 in our investment account at Phillips Hager & North. For the past number of years, we have been withdrawing \$60,000 per year from our investment 'income'. However, from this point forward any withdrawals of this nature will reduce our 'principal'. Depending on what rate of withdrawal we choose, those funds will be fully depleted at some point. The math is pretty straight forward. As a congregation we have to decide what this loss of income means to us in terms of the overall budgeting of our operations.

In the coming months the Board of Trustees will have to deliberate and decide on what would be prudent for us to retain in investments in order to 'protect and preserve' our assets (our buildings) going forward. It will better guide us on what may still be available to spend on operations (from our investments). I think it is fair to say that less money will be available in the not too distant future. Other sources of income will have to pick up the slack if we are to maintain and expand current levels of services/operations.

Indeed, some important decisions need to be made going forward. We look forward to the discussion and further deliberation.

Thank you once again to all our trustees.

Treasurers Report

2017 was an unusually active year financially for Squamish United. A combination of keeping operations going while in the shared facility with the Anglicans, finishing the construction contract and closing soft-cost activities for Centrepoint, while supporting four new-comer families in our community meant we had more than our fair share of financial transactions to attend to in 2017.



To give a high-level summary:

 2017 saw the expenditure of the final \$846K in the completion of Centrepoint. Although we are awaiting a final reconciliation by the project manager, based on expenditures to date our multi-year cost in total for Centrepoint (soft & hard costs combined over 5 years) was \$1.95M (construction costs = \$1.6M, remainder = soft costs).

- a. We spent an additional \$73K in 2017 for various capital items to set up Centrepoint (chairs, AV system, curtains).
- We liquidated \$739K from our building GIC in 2017 and pulled an additional\$206K from investments to complete Centrepoint and fulfill operational expenditures in 2017.
- 2) Preliminary aggregate figures (operations & investments) for 2017: Revenues \$123K, Expenses \$150K, Deficit \$27K
- 3) The net worth of Squamish United remains largely unchanged at \$2.3M.
 - The key point is that we have now transitioned the majority of our assets from liquid instruments into real estate (the Centrepoint facility). The residual liquid investments remaining after all Centrepoint costs = \$254K at year end.
- 4) We expended \$46K in supporting the four new-comer families in 2017, partially offset by some \$10K in donations received to this project over the year. Funds remaining for disbursement are \$54K.

Ministry and Personnel Report

Committee membership: Marilyn Caldwell, Kevin Haberl, Louise Martin and Nairn Stewart (Chair). Trevor Harris stepped down from the Committee late in the year and we thank him for his dedicated service to the Committee.



Because of combined worship services at St. John's Anglican Church earlier in the year and the transition to Centrepoint in October, most of the Committee's efforts during 2017 were concentrated at the end of the year. There were many transition issues such as staffing of the office (for example, holiday replacement and discussions about daily coverage of the office on weekdays) and challenges for the staff in the new setting as the roles of the secretary and minister have changed. Increased interaction with the public has made it difficult for staff members to complete their work but is seen as a positive development in

that Squamish United Church now has a greater presence in the community. Also, the Children and Family Ministry Coordinator position was created. In October the Committee brought a number of concerns/challenges to the Board for the Board's consideration and help.

The Committee will continue to support the staff as the transition to Centrepoint continues and as exciting new programs such as the Before and After School Program unfold. Committee tasks for 2019 include check-in meetings with staff members, assurance that criminal record checks are in order, a review and update of staff job descriptions, performance evaluations of staff members, and hiring staff for the office when Jody retires in October.

Mission and Service Report



The Mission and Service (M&S) giving's support needs beyond the local church, through the United Church of Canada. M&S funds organizations and projects in Canada and elsewhere. Its aims are very different from the historical missionary goals of "saving souls". Instead funds are used for a wide range of initiatives and organizations. In Canada it supports 64 community initiatives such as; families affected by the justice system when a family member is jailed, drop in centres for mothers and others in less fortunate neighbourhood, support for small churches, conferences to provide leadership to

ministry personnel, Christian camps and others. M&S interacts outside of

Canada with 94 partners in 22 countries, with ecumenical organizations, social justice causes, etc. If there is a large scale disaster the United Church quickly works with other churches through an organization known as Action of Churches Together (ACT). This gives an almost immediate financial response to disasters.

The M&S committee presents the weekly "Minute for Mission" talk, highlighting an example project of M&S. The Committee members are Christine Tribe, Barbara Stover, Pat Wilson and Hugh Kerr.

Besides regular M&S designated giving's by the congregation, funds also are raised by items taken for **recycling to the local Bottle Depot and donated to account # 205**. In 2017 giving's were \$12,879.50.

The Committee is very grateful for these donations. We ask that you continue to support M&S through regular giving in 2018.

We would also welcome new members of the M&S Committee. No application forms, or experience are needed. Only a desire to inform yourself and the congregation about Mission and Services activities in Canada and around the world.

Family and Children Ministry



Now that we are in a new building with new possibilities it has been fun to see those expectations turn into realities. These past 4 months (September - December 2017) have seen a lot of change and growth in Family Ministries - and it will continue to grow from here!

In our Sunday morning services, we can really see the change. The young families that are coming are so great that I am in need of help - what a great problem! On average in 2017 I was getting 4 children, now in 2018 the

average is 8 and I have had up to 14! We have 6 families that are regularly attending Sunday morning services, and we have the potential to have many more with our welcoming program! Currently I am creating each week's program from scratch myself based on the lectionary readings of the week and/or Rev. Millard's sermon. I like the children to consider Sunday morning as their own "Children's Service" (as opposed to "Sunday School") so that they feel are a part of the congregation.

Messy Church has been a great success! We have had one in every month (save January) since September in our new space. Now that we have gotten to know the space each time is more and more fun and educational! We get upwards to 45 people each month - most of which do not come to Sunday morning services. Messy Church happens on the first Friday of the month and includes a story (celebration), dinner and craft. Our favourite messy Churches have been when the UCW provides a home cooked meal! Thank you UCW!

In 2018 we have started a new program of "Family Music class" which is a drop in, by donation class for young families. This program has attracted on average about 8 children a week plus their caregivers and I have had up to 16! All the donations are allocated for family ministry programming.

"Messy Church has been a great success" There is a lot in the works for 2018 - most significantly a before and after school care program for which we have received a massive grant from presbytery! Thank you to all who worked on this grant, especially Kaija Monroe. Other programs to come are a children's choir, family fairs, and a weekly family series.

Many blessings and thanks to a wonderful year! Here is to many more!

Refugee (Newcomer) Committee Report

The Refugee / Newcomer Committee includes Vicki and Kevin Haberl, Louise Martin, Nairn Stewart and Hugh and Elizabeth Kerr. To date we have been involved in the welcoming and care of 4 refugee families. Each is supported by its own group, but one member of our own Committee is both an active member of that group and a liaison to Squamish United.

The families arrived on very different dates, due to different circumstances for each. The first arrived in May 2016, the next in October 2016, then one in December 2016, and the final one in November 2017. The last is living in a suite which the Haberl's had built.

One of the newcomer families: the Sadouns

Sponsorship only extends one year. Hence three of the families are already through their sponsorship period. In general, they are progressing well on their own. In some

cases, especially where the parents arrived with limited English, the groups continue to give some help with English lessons, transport to some classes, and child care. There is further need for some help with these, especially for one family. All of the fathers now have work, and one mother also works part time. Two of the fathers spoke very good English on arrival, and had no problem securing jobs. The other fathers are increasing their work hours as their English improves. The mothers who lack English also are taking classes.

All of the school age children quickly learned English and enjoy their schools.

All in all the settling of the newcomers has been very successful. Two of the families are in the process of applying to bring family members to Canada. These applications can take years, but the groups are organized and ready to help more newcomers.
