This year of "Spirit Kids" has been a lot of extra work for all the staff but every one of us loves the program when we are working in it and we are constantly blessed by kids and parents who tell us how much they appreciate the program and work that we do. Lisa reports that we had 60 children in our programs in 2019. We continue to hope this will grow in a way that it will assist us financially, but in the meantime it has gotten our name out into the community in ways it never has been before and most importantly we are living into our call of ministry as a congregation to serve

our community and its needs.

In the last year we have seen more families come to our drop-in music class, Messy Church and Sunday services. Some of this is because of our community connections entirely. Thank you to Kayla for working above and beyond many hours to make these ministries successful.

In 2019 many of you have discovered where there are vital needs for ministry. We were able to with the assistance of a grant build up a bit of a missing seniors ministry with



Elaine Graham at the helm. I am so thankful for her work and assistance in so many areas. UCW is always at work providing meals, fundraisers, coffee and more. Hugh and the finance team work tirelessly to help us figure out how to move forward with our financial needs. M&P have spent more hours than any of us can imagine attempting to get protocols, job descriptions, salaries, and hiring practices up to date. Grace has been steering a fast-moving ship through a difficult year for our board as they grapple with our financial concerns. Over the last year Arlene Robinson has become a part of our community and she blesses us weekly with her gift of music. Lisa Cameron who quickly became a part of the team has worked many hours to keep this ship afloat. There is so much more to say and I will never cover it all. If I have missed your work and ministry it has not been intentional. We are so blessed by so many.

As I look back on 2019, I celebrate the ministry of my colleagues here who daily pour out their life's energy and gifts for the sake of God's love in this community. As everyone's schedules become increasingly busy, we often turn to staff to do things that volunteers used to do and the Squamish United Church staff steps up. That has led to an increase in staffing budgets, which carries its own challenge, but I want to shine a light on the gifts of human love and expertise offered by our staff.

I also celebrate all who offer their time and gifts on a voluntary basis. Every day you come to the church, offering your gifts, and yourselves: in the music, the meals, the visits, the phone calls, the leadership, the administration, and the worshipping that happens every day, every week. We have our challenges finding the people we need to do all we long to do, finding the financial resources to sustain our mission, discerning a vision and some goals for the next years. I am grateful that God has called me here. I wholeheartedly believe that God is up to something important here. Board of Trustees Report

Hello everyone, the Board of Trustees had another rather slow year with little activity.

The Trustees investment account is now down to our last \$100,000. It is invested in a term deposit at Vancity/Squamish Savings.

The Trustees in cooperation with the Regular Church Board and you, our congregation, must decide on how best to spend those funds and over what period of time. They were originally set aside in 2017 to be available in the event the money is needed by the congregation to help us transition to a smaller



operation if ever current operations expenditures exceeded revenues and had to cutback due to lack of available cash on hand. The regular board is conversing on the issue of how best to proceed in 2020 and beyond. The Trustees await a report from them. Any recommendations we *may* have will then be presented to the congregation for final determination. Thank you.

Treasurers Report

March 2020

This year marks the second in Centrepoint. As can be seen in the accompanying detailed statement the overall givings from PAR and envelopes were about \$66.2K, very close to the budget set for 2019, and very similar to the 2018 givings. When other donations are included, including \$2,780 from the UCW, the total donations were about \$74.6K. Thank you for your continued support.



Other income also is shown in the financial statement. A major source of income was \$50,375 from four grants, most of which was designated for Spirit Kids or the summer camp. Fees from parents for these two activities totaled about \$81.6K. Additional funding was received from fund raising activities (\$4.3K) and facilities donations (rent) (\$5.3K).

Hence the overall income was about \$222K. (M&S givings shown on the financial report are sent to the main church.)

The operating expenses (office, audit, presbytery allocation, worship, utilities, phone, insurance, strata, etc.) totaled about \$69K, (including \$21K for sound panels and blinds). Church salaries and benefits totaled about \$130K, leading to a deficit of about \$104K for the church.

New Program initiatives (Spirit Kids, summer camp, Seeds of Hope) had overall earnings of about \$19K, as shown in the accompanying statement. The summer camp broke even. Altogether this gave a total deficit of about \$85K.

The overall deficit resulted in a significant reduction in our liquid assets. By the end of 2019 we had spent all of the \$100K which had been transferred from a GIC early in 2019, as shown in the balance sheet. This left total assets at the end of 2019 of only about \$141K : a \$100K GIC, about \$18K in the building fund, plus \$23K in the operating account.

The expected deficit for 2019 was expected to be only about \$50K.

The difference is due to several aspects. First, the expenses include the costs of the sound panels and new blinds. Second, we are still learning about reasonable expectations for both the New Programs and rent ("facility donations"). This was the first year with an increased enrolment for Spirit Kids, and its associated costs (salaries, other costs). We were successful in obtaining grants totaling about \$50K to support the new programs, but it was found that more staff were needed than originally budgeted. The organizational structure of Spirit Kids has been changed to optimize income. We also had less income from rent than we had hoped, despite installing new sound panels. It is hoped to improve this by more advertising, and word of mouth.

An "as is" budget for 2020 is given with the 2018 and 2019 statements. The Board has had several meetings about next year's budget and its predicted deficit. Personnel from the "Pacific Mountain Region" (which replaces the "Presbytery") have also given us input. Further discussions will take place very soon. The "as is" budget for the church alone for 2020 is predicted to result in a deficit of about \$97K. This would use up almost all of our liquid assets. We recently received a grant of \$31,700 in support of Spirit Kids in addition to a final payment of \$6375 from an earlier grant. With this support, and assuming the same Spirit Kids enrolment as last fall, and an average number of staff, an income for Spirit Kids (including the \$31.7K in grants) of about \$45K is predicted. A budget for summer camp is also shown, with a net income of about \$12.7K. With these estimates the overall deficit is estimated to be about \$40K. However, the possible incomes shown for Spirit Kids and summer camp are subject to small changes in the enrolment and in the number of staff. **Hugh Kerr, Treasurer**

Ministry and Personnel Report

2019 continued to be a challenging and interesting year for the M&P Committee. Marilyn Caldwell continued to co-chair the committee with Cindy Roy. Louise Martin also remained as a committee member. 2019 was the first year that the Spirit Kids Summer Program was offered, and September was the second year of the actual Spirit Kids Before and After School Care Program. M&P gained a greater understanding of the complexities and necessary on-going workload that is required to sustain such a large church sponsored undertaking. Our early tasks included researching and introducing to the Board an alignment of the Minister's salary according to United Church of Canada guidelines. This required extensive research and formulation. A special thanks to Cindy Roy for taking on this task. We now have the salary aligned correctly. From there, our Committee had the challenge of working together with others on the Board to plan for the Minister's three-month Sabbatical Leave starting the at end of April. A committee was struck, and participants worked hard with the Board to fill that position to the best of their ability. It was decided that the congregation would hire Rev. Debra Bowman and Rev. Elaine Graham for Sunday mornings, pastoral care and for some supervision of the Spirit Kids Summer Program. Our other major challenge in the spring was the hiring of personnel for the Summer Programs without knowledge of the number of children that would be attending. M&P applied and was granted a Sumer Student Grant from the United Church of Canada.

Unfortunately, we were not able to fill that position and the grant was returned. Although the camps were well received by families and children, staffing was a daily concern, both in terms of management and childcare.

In late March, we were informed we no longer had a custodian. In April a custodial company was hired to provide services to the church. To date, they have worked effectively with Pat Wilson in the process of moving furniture and cleaning the sanctuary on Saturdays. There were occasions when the service was not available. M&P covered the custodial service.

M&P has introduced the Vacation Schedule document to staff. It is hoped that with M&P knowing ahead of time when people plan to be away, staffing can be better planned. During the 2019-20 year, no staff members have used the document. It is hoped that it will gain traction during 2020.

Reverend Millard requested Vacation in August and November. The Sunday Services were covered by Reverend Elaine Graham. Lisa Cameron requested Vacation in March. This was covered by Cindy Roy and Deb Kent. Elaine Graham completed her work through the Seeds of Hope Grant where she had developed a seniors-focused daytime program series. She also continued to facilitate the Pen Pal Project, which was celebrated with a wonderful cake and pen pal revealing event at the end.

New job descriptions were created or rewritten for the Child Care Associates and Manager for the Summer Program, the Custodial position, the Director of Family Ministries, the Manager Position for Spirit Kids. In addition to the work **done on** job descriptions, contracts were also written or updated to reflect the changes in positions. Cindy Roy developed five contracts for Summer Camp Personnel alone. Thank you.

Successful probationary performance evaluations were completed on a number of staff. A Performance evaluation was completed for the Minister through a series of interviews. The Minister took the reflections from that input to use as part of her Sabbatical Leave.

We are very fortunate to have dedicated and committed staff and volunteers at Squamish United Church. It has been particularly challenging for them to supervise and cover staff for the Spirit Kids Program. Thank you to everyone. M&P will continue to work with our staff and provide support to the best of our ability.

Mission and Service Report

The Mission and Service (M&S) donations support needs beyond the local church, for a wide variety of organizations and projects, in Canada and elsewhere. In Canada the projects include: community and justice work, such as ministries that advocate, provide housing, mental health treatment, and employment training for marginalized Canadians. It helps with support for small churches, summer camps, theological education and reconciliation activities. It has partners in Latin America (8 countries), Asia (5 countries) Africa (8 countries). Priorities include access to land to grow local food, safe local water, food security, sustainable livelihoods, human rights, peace building, and reconciliation activities. For disaster relief M&S partners with other churches through an organization known as Action of Churches Together (ACT). ACT's financial support allows worldwide immediate financial response to disasters.

The M&S committee at present is Christine Tribe, Barbara Stover, Pat Wilson and Hugh Kerr. It presents a weekly "Minute for Mission" to highlight an example project of M&S. In 2019 donations by Squamish United Church totaled over \$8800. This includes proceeds from recycling items at the local Bottle Depot, (account # 205), which were over \$300. The M&S Committee is very grateful for these donations. We ask that you continue to



support M&S through regular givings in 2020. We would also welcome new members of the M&S Committee. No application forms, or experience, are needed. We only require that you have a desire to inform yourself, and the congregation, about the many M&S activities.

United Church Women Report

The UCW membership consists of 16 active members. We are part of the "Pacific Mountain Region UCW". The 4 Pillars of our Purpose are: Christian Witness, Study, Fellowship and Service. We meet the second Wednesday of each month from September to June, starting our sessions with a "Devotional" reading and finishing with delicious refreshments from our host home, where fellowship is the focus.

We would welcome any women who would like to join us as a member or even just for one evening.

Every 3rd and 4th Sunday, we provide coffee service post church and three times a year we provide food for "Messy Church". UCW also provided food for the SUC AGM in March and fruit plates for the pancake breakfast in September.

Refugee (Newcomer) Committee

Squamish United has been supporting refugee families through its Refugee / Newcomer Committee since 2016. In 2019 the Committee was Vicki and Kevin Haberl, Louise Martin, Nairn Stewart, and Hugh and Elizabeth Kerr. We have been involved in the welcoming and care of 5 Syrian refugee families. The Haberls have one of the families in a suite in their house.



The families arrived at different dates starting in May 2016. The fifth family arrived in October 2019, with 7 (!) children. The mother is a sister of a mother of one of the original families, but they had not seen each other for over 5 years. You can imagine their joy on being reunited. Members of the Committee and the rest of the sponsor groups maintain strong connections with the newcomer families. All of the children learn English at an astonishing rate, and go to regular schools. The parents learn English through regular lessons and tutoring.

The fathers are all employed, and one of the mothers now is a preschool worker. They have great culinary abilities. One of the families sells Syrian food at the local summer market. They are available for catering their Syrian meals for parties or other special events.

The settling of the newcomers has been very successful. Now two of the original families are applying to bring family members to Canada. Some members of the congregation have donated this year for the newcomer families, for which we are very thankful.

 - 2. Opening Comments:

Rev Karen Millard presented a video highlighting 2018 at Squamish United Church. Grace Halvorson talked about how 2018 was a year of transitioning into the new building. Some final elements such as the cross outside are still missing. New welcoming signs were just donated by Rob Pedersen. The sound panel installation is completed. This expense was paid with the original money allocated for the building.

The church's children's ministries have been very successful and 2 grants have been received. The community is acknowledging what we do.

3. Motion for Voting Privileges:

MOTION: Moved by Deb Kent, seconded by James MacDonald that voting privileges be given to all members and adherents in attendance. Carried.

4. Review and Adoption of minutes of 2018 AGM:

MOTION: Moved by Kaija Belfry-Munroe, seconded by Kevin Haberl that the minutes of the April 22, 2018 Annual General Meeting be adopted. Carried.

5. Acceptance of 2018 Committee Reports:

MOTION: Moved by Marilyn Caldwell, seconded by Valerie Stainton that the Committee Reports except for the Nomination Committee be received. Carried.

Marilyn Caldwell spoke about the development of the M&P ministry. She explained that Rev. Karen Millard requested a sabbatical leave last spring. The United Church of Canada allows a paid sabbatical after 5 years of uninterrupted service. The purpose of a sabbatical is to reflect, learn and to recharge. A sabbatical committee has been formed. Karen's sabbatical will start at the end of April until the end of July. Karen has decided to take the sabbatical during a quieter time in the church. The worship committee, M&P committee and the board are involved in the planning of covering Karen's sabbatical leave. It is important to keep the church's momentum going. The church has a lot staff and ministries, including pastoral care as well as the before and after school care. We are lucky to have 2 ordained United Church ministers in Squamish. Both have been approached to help cover Karen's leave. The ordained ministers, Deb Bowman and Elaine Graham, will be covering 2-3 Sunday services per month. The 4th Sunday will be covered by a lay minister. A detailed plan of the sabbatical coverage will be presented at the next board meeting.

Kayla Mak spoke about the family ministries. Both Spirit Kids, the before and after school care program and children's church and messy church are growing. Next month Messy Church is planning a big Easter celebration. A new grant for Spirit Kids has been received for 2019. We already have children signed up for September 2019 care.

Question from Pat Yendall: How many kids are allowed and how many kids do we currently have signed up in Spirit Kids?

Kayla reported that we are allowed 24 kids. It is 12 kids per adult. On average at the moment we have 5 children in morning care and 11 in the afternoon care. Children's church was very busy over Christmas. We have over 20 kids coming to children's church. The kids were split up into age groups. In the future we might even ask to use the second pre-school room for children's church. Currently we have approximately 6-7 children per Sunday. This historically is a slower time of the year.

Rev Karen Millard spoke about how busy the past year was and how taking a sabbatical is the right time for her. Karen talked about how our staff and programming at the church is functioning well. Elaine Graham and Kayla Mak are managing their programs well. We will be having a busy summer with child care summer camps happening every day. The caring ministry team is in place; it is very important to have help available when needed. Our community doesn't only have seniors who are in need but also struggling families with children. We have developed an excellent relationship with our community partners. We support one another and our programs. This is a gift that we had hoped for. When we receive grants such as the grant we just received for our child care program the community is watching. We are seen as caring for our community. Our place is moving and thriving even if it's not necessarily bringing in money. We can celebrate how we are impacting our community and we have to trust that God is with us.
